Dear Chair Collins, Ranking Member Murray, Chair Murkowski and Ranking Member Merkley,

The 50 undersigned organizations participating in the Coalition for Healthier Schools strongly endorse \$100 million in funding in FY 2026 for the U.S. Environmental Protection Agency's highly effective programs to help schools improve environmental health for children, teachers and staff.

The funding meets a critical unaddressed need for a modest federal investment. Support for the funding is detailed in "dear colleague" letters signed by [20 Senators](#) as well as [30 House members](#). EPA programs to improve indoor environments for children have been supported across multiple administrations of both parties.

EPA's indoor air and children's health programs have delivered high quality, science-based guidance, training, and resources to schools across the country for decades. EPA's [IAQ Tools for Schools](#) has been the federal government's principal source of assistance to schools for preventing and resolving indoor air quality problems, such as reducing asthma triggers, improving ventilation, and properly managing cleaning products and chemicals. This tool is especially valuable for low income and rural-remote schools.

Investments in indoor environmental quality yield measurable returns in attendance, cognitive performance, and reduced liability and health costs.
